**Beem It Lunar New Years' Promotion**  
**Terms and Conditions**

1. Information on how to enter and prize details set out in all communications regarding the Beem It Lunar New Years' Promotion (the "**Promotion**") form part of these Conditions of Entry. Any entry not complying with these Terms and Conditions is invalid. Entry into this Promotion and the acceptance or receipt of a prize by a winner(s) is deemed as acceptance of these Terms and Conditions.
2. The Promoter is Digital Wallet Pty Ltd ABN 93 624 272 475 of level 10, 68 Pitt Street, SYDNEY, NSW 2000 and can be contacted at the following website [www.Beemit.com.au](http://www.Beemit.com.au) (the "**Promoter**"). The Promoter is an authorised representative of Commonwealth Bank of Australia ABN 48 123 123 124 AFSL 234945.
3. The Promotion commences at **00:00 AEDT on Monday 4 February 2019** and closes at **23.59 AEDT on Monday 11 February 2019** (the "**Promotion Period**").
4. Entry into the Promotion is open to Australian residents who satisfy the following eligibility requirements ("**Eligibility Requirements**"):
  - Entrants must be a fully registered Beem It user– this means they have proceeded through the Beem It App registration process and have added a valid Mastercard or Visa debit card issued by an Australian bank;
  - Entrants must be aged 18 years and above; and
  - Are not employees or members of the immediate family (spouse, parent, sibling or child) of employees of the Promoter or their related entities directly involved in the Promotion (as determined by the Promoter).
